### Overview

### Experience

- + Successfully represented American Biltrite in a crucial legal victory in three New York appellate cases, obtaining summary judgment based on the lack of causation. Plaintiffs alleged lung cancer from Amtico vinyl asbestos floor tile exposure, but American Biltrite successfully argued the tile's inability to contribute to the disease and challenged the lack of scientific foundation in plaintiffs' claims. The appellate court reversed prior denials, stating that plaintiffs were not exposed to sufficient asbestos levels, and there was no demonstrated correlation



between floor tile asbestos and lung cancer risk beyond the general environment.
