owner against the hotel management and development companies for breach of contract, construction defects and mismanagement. The matter was resolved after multiple mediation sessions involving more than a dozen parties and their insurance carriers.

- + Obtained a unanimous decision in an International Chamber of Commerce arbitration involving claims by the owner of a hotel in El Salvador against the management company. In a landmark decision, the highest court of El Salvador confirmed the decision.
- + Ran discovery in a RICO case brought against a national union in the US District Court for the Eastern District of Virginia. The case settled on favorable terms soon after a "smoking gun" was obtained in discovery.
- + Recovered \$28 million in a AAA arbitration filed by a facilities management company against a large school district. Claims for failure to pay for services rendered were awarded and counter-claims for breach of contract were significantly mitigated.
- + Settled at private mediation a case involving the death of a company employee in which the family pursued the company's client for negligence. Claims for defense and indemnification between the company and its client were successfully resolved in conjunction with settlement of the main case.
